SEE OUR MISSION STATEMENT IN SCHEDULE O., IT ACCOMPLISHES THIS PROGRAM SERVICE BY PURCHASING OVER 2,000 BOOKS, E-BOOKS, AUDIO AND VIDEO RECORDINGS ANNUALLY.
